A description of the submitted software is listed below.

1. Sportuno

Sportuno is a sweepstakes game where players are provided with equal amounts of virtual credit to bet and trade on events. Tournaments are limited by time and the designated markets that can be played. The objective of the game is to successfully bet and trade on the available markets across the allotted time period; the winning players will be those with the largest virtual bankroll at the time the Tournament closes. Winners will be paid according to the rules of the individual Tournament through a pre-configured paytable.

Sportuno can either be integrated with an operators existing Player Account Management system, or be deployed with its own Player Account Management system.

The odds for Sportuno Tournaments are sourced via live feeds from Sportuno's odds providers and may not accord exactly with those available in the operator's website. However, all players will be subject to the same odds within each Tournament making game play fair to all.

So, in essence, Sportuno offers standard wagering functionality, but wrapped within a tournament model. The wagering functionality match that exactly of industry standard betting engines; consumption of real time feeds; presentation of betting information; bet placement; cash-out; resulting; settling; etc.

Sportuno verifies all individual event result data directly after an event and before finalising each Tournament. Sportuno's declared result for both events within a Tournament and each Tournament itself is official and will only be changed in the event of an obvious error.
